

PRIVACY POLICY

Educate Girls is committed to the ethical collection, retention and use of information that you provide to us about yourself ("Personal Information") on this site www.educategirls.in ("Site")

Your Personal Information may comprise the following:

- your name
- your email and mailing address
- your telephone number
- your payment processing details
- limited personal details
- Any other data as Educate Girls may require

The following Privacy Policy sets forth our understanding with you on the collection, use and protection of your Personal Information. Please read the entire Privacy Policy.

YOUR USE OF THE WEBSITE CONSTITUTES YOUR CONSENT TO THE ALL THE TERMS AND CONDITIONS CONTAINED IN THIS PRIVACY POLICY (AS AMENDED FROM TIME TO TIME) AND YOU SHALL BE BOUND BY THE SAME.

1. Site Browsing

- 1.1 You browse the Site anonymously. We do not require you to identify yourself or reveal any Personal Information while browsing through the Site. However, you may not be able to access certain sections of the Site or interact with us without supplying us with Personal Information. For instance, you would not be able to transact at the Site or make any donations at the Site, without providing the Site with Personal Information.
- 1.2 While you are browsing through the Site, the Site's operating system may automatically record some general information ("General Information") about your visit such as:
 - the date and time you visit the Site, along with the address of the previous website you were visiting
 - if you linked to us from another website
 - the type of browser you are using (such as Internet Explorer version 'X')
 - which 'hit' it is on the Site
- 1.3 The General Information is not Personal Information. Educate Girls tracking system does not record personal information about individuals or link this information to any Personal Information collected from you.
- 1.4 The General Information is used by Educate Girls for statistical analysis, for tracking overall traffic patterns on the Site and to gauge the public interest in Educate Girls and the Site. Such General Information may be shared by Educate Girls with any person, at Educate Girls' discretion.

2. <u>Usage of Information</u>

2.1 Personal information will be used by Educate Girls for internal purposes including the following:



- sending e-mails and updates, Educate Girls Annual Report, regular updates on the utilisation of donations by Educate Girls, appreciation e-mails and other updates.
- processing your donations to Educate Girls
- maintaining an internal confidential database of all the Personal Information collected from donors and prospective volunteers/employees
- evaluating and administering the Site and Educate Girls's activities, responding to any problems that may arise and gauging visitor trends on the Site.Disclosure of Personal Information by Educate Girls
- 3. Educate Girls, access to Personal Information collected by Educate Girls will be given only to those persons who are authorised by Educate Girls and third parties hired by Educate Girls to perform administrative services.
- 4. Educate Girls may share Personal Information with any of persons who are associated with Educate Girls, including companies and non-governmental organisations affiliated with Educate Girls in any manner. Educate Girls will retain ownership rights over such information and will share only such portions of the Personal Information as it deems fit.
- 5. Educate Girls is not liable in any manner whatsoever for the loss, damage(whether direct, indirect, consequential or incidental) or harm caused to you by the misuse of your Personal Information by a third party who is not an employee of Educate Girls.
- 6. Notwithstanding anything contained herein or any other contract between you and Educate Girls, Educate Girls reserves the right to disclose any Personal Information about you without notice or consent as needed to satisfy any requirement of law, regulation, legal request or legal investigation, to conduct investigations of breaches of law, to protect the Site, to protect Educate Girls and it's property, to fulfil your requests, to protect our visitors and other persons and if required by the policy of Educate Girls.

- 7.1 Educate Girls endeavours to use up-to-date security measures to protect your Personal Information.
- 7.2 Educate Girls however does not make any express or implied warranty with respect to the security measures that it may employ from time to time for the protection of the Personal Information.
